- 🐾 Briefings are dependent on COVID-19 Rules. More details will be provided.
- 🐾 Dogs will be run in height order with dogs being handled by the same person separated into different staged groups. When possible, dogs will be staged in groups of 5 or less.
- 🐾 Judge of Record and Event Official dogs may be judged prior to the official start time or as the first blind(s) of the Event.
- 🐾 Move ups are at the handler's discretion. The Trial Secretary will accept move up requests and any additional applicable fees until 10 mins after the conclusion of the relevant trial/class.

### Entry Information

- 🐾 Dogs are required to have a Barn Hunt Registration number to compete in a Barn Hunt Trial. In order to get your dog a Barn Hunt Registration number, you can register your dog online at <http://www.barnhunt.com>. **You cannot submit an entry without a valid Barn Hunt Number.**
- 🐾 All dogs must be entered in only one class level and type per event. (i.e. a dog cannot be entered in Novice B on one day and Open A on the next.) Dogs may enter both the Instinct Test and Novice class in the same trial until the dog has earned the RATN title and then you cannot enter Instinct.
- 🐾 No toys or food will be permitted in the ring.
- 🐾 Entries will be accepted by mail, in-person and by email. Cheque, cash or e-transfers are acceptable forms of payment. An entry is not considered valid until payment is received.
- 🐾 A returned cheque does not constitute a valid entry. A \$50.00 fee applies for all returned cheques.
- 🐾 All dogs must be on a short leash and under control while on trial grounds except while showing. **FLEXI LEASHES ARE NOT PERMITTED ON SITE.**
- 🐾 Any dog behaving in a threatening or aggressive manner toward another dog or a person may be dismissed from the trial if justification is found to do so by the judge and/or the trial committee.
- 🐾 The safety of the dogs and the rats are our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and physically able to perform all course elements.

### Withdrawal and Refund Information

- 🐾 **Withdrawing due to COVID-19:** Attendees who enter a scheduled Event but then must withdraw due to suspected or confirmed COVID-19 or direct exposure to/close contact with a COVID-19 patient will receive a full refund minus a Club administration fee.
- 🐾 **Refunds** offered only for injured or sick dogs with veterinary note. Requests for refunds must be made by the closing date. Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the Event Committee.
- 🐾 **Bitches in season** are eligible for entry but will be required to be kept separate from all other dogs and will be run at the end of their class/trial. Entry fees for bitches that come into season will be refunded until closing time of the trial if you wish to withdraw. After the trial closes, entry fees will not be refunded. If bringing a bitch in season, the trial secretary must be notified prior to the trial. Failure to notify the Trial Secretary results in a disqualification and dismissal from show grounds.

- 🐾 **Cancellation Policy:** Every attempt will be made to hold this event as scheduled. In the event of changes to Provincial/Local COVID-19 restrictions, or an “Act of God” such as fire, flood, etc., the event may be cancelled. We will make every attempt to contact entrants and inform them of the cancellation. Entry fees will be refunded as appropriate.

### **Event Grounds / Ring / Blind Information**

- 🐾 Please pick-up after your dog and dispose of waste in appropriate containers on site.
- 🐾 Event grounds include the private property located at 1739 Courtright Line, Brigden, ON specifically the training building, parking lot and surrounding grass areas. Training building is accessible from the east side driveway only (indicated by Canine Companion Training Academy sign). Event grounds are not handicapped/wheelchair accessible. Ample parking available.
- 🐾 1 Ring is located indoors with rubber floor matting over cement floor, enclosed with 4' PVC fence.
- 🐾 Blind area is 10'x20' and is located 20' from the ring gate. Each competitor will exit the blind in order, not crossing the path of another competitor.
- 🐾 Competitors are encouraged to crate out of cars. **There will be LIMITED INDOOR CRATING.**
- 🐾 Please bring adequate water for you and your dogs. There are limited restaurant options near the trial. A portable washroom will be available at the trial site.
